

NOTICE TO BIDDERS OF THE INTENTION OF McCURTAIN COUNTY RURAL WATER DISTRICT NO.8 TO LET CONTRACT FOR HIGHWAY 70 ROCK CREEK RELOCATION IMPROVEMENTS.

SEALED PROPOSALS addressed to Randy McMurl, Manager, McCurtain Co. RWD 8, 1803 N US Hwy 259, Broken Bow, Oklahoma 74728, will be received until 2 P.M., Tuesday July 7th, 2026 for furnishing all labor, equipment, materials, supplies, and supervision necessary for the construction of 2-inch water main associated with State Highway 70 Improvements. The work is being performed under the direction of ODOT. Bids will be opened and read aloud at such time at the McCurtain Co. RWD 8 (Mt. Fork Water) Water Office, 1803 N US Hwy 259, Broken Bow, Oklahoma.

PLANS AND SPECIFICATIONS may be examined without charge at the office of A.L. Franks Engineering, 118 East Broad Street Texarkana, Arkansas 71854, or at McCurtain Co. RWD 8, Broken Bow, Oklahoma. One copy of each set of documents may be purchased from A.L. Franks Engineering for \$125.00. **No refunds will be made.**

A CERTIFIED OR CASHIER'S CHECK, or an acceptable bid bond in an amount not less than five percent (5%) of the total bid shall accompany each bid as a guaranty that, if awarded the contract, the bidder will promptly enter into contract with RWD #8 and furnish bonds on the forms provided.

THE SUCCESSFUL BIDDER OR BIDDERS will be required to furnish a Performance and Payment Bond, each in the amount of the contract, written by a responsible surety company authorized to do business in the State of Oklahoma that is satisfactory to the Owner.

BIDDERS ARE expected to inspect the site of the work and to inform themselves of all local conditions. The time of completion shall be 150 calendar days including Saturdays, Sundays and legal holidays.

ATTENTION OF BIDDERS is directed to Section 4 of Act 74 of 1969, requiring that not less than the general prevailing rates of per diem wages for work of similar character in the locality where the work is performed shall be paid all laborers, workmen and mechanics employed in the construction of public works.

EQUAL OPPORTUNITY IN EMPLOYMENT: All qualified applicants will receive consideration for employment without regard to race, color, religion, sex or national origin.

THE SUCCESSFUL BIDDER will be required to furnish evidence of registration with the State Department of Finance and Administration in compliance with Act 125 of 1965 prior to engaging in the performance of this Contract.

NO BID may be withdrawn after the scheduled closing time for receipt of bids for at least 90 calendar days.

IN CASE of ambiguity or lack of clearness stating the price in the bids, McCurtain Co. RWD #8 reserves the right to consider the most advantageous construction thereof, or to reject the bid.

MCCURTAIN RURAL WATER DISTRICT #8 reserves the right to reject any or all bids, waive any minor informalities, and to award the contract to the lowest responsive, responsible bidder.

CONTRACTORS are cautioned that qualified bids will be subject to rejection.

CONTRACTORS are specifically advised that any person, firm, or other party to whom it is proposed to award a subcontract under this contract must be acceptable to the Owner.
